Dear Dr. Böhnecke,

This is another letter on the troublesome subject of the SCOR Budget for 1963. Following Dr. Wooster's letter to you on the clarification of the UNESCO Programme and Budget, I feel that we ought to alter the SCOR Budget somewhat drastically.

I enclose a Statement of what we might now consider and you will see that the only way I have balanced it at all is by reducing the expenditure. I feel that this is probably not unreasonable as we might well obtain a further contract from UNESCO similar to the one which they gave this year for the Intercalibration Tests. We cannot guarantee this, of course, but it is a reasonable guess.

Anyway, I should be glad if you would consider these figures and let me know whether or not this is a fair Statement to present to the Prague Meeting.

Up to this point, ICSU has not planned to give any money to SCOR in 1963. But if you consider that ICSU should do so, I should be grateful if you would send me a few lines on the scientific purposes for which it might be used. The Treasurer is keen to present what might be called "Supplementary Estimates" to the Executive Board with a scientific purpose in each case.

I look forward to your reply.

Dear Mr. MacLennan,

Thank you very much indeed for the troublesome work you had with SCOR's budget estimate for 1963. I think, for the time being we cannot do any more, that means you can present this paper to the Executive Board of ICSU at Prague, however, with some reservation.

1.) It may happen that the SCOR Executive at Paris decides to present some other proposals for Working Groups, etc.

2.) It seems to me that the estimated sum of \$ 15.000.-- for National Contributions is too large. Even if USSR would perhaps pay \$ 3.000.--, the total amount would not exceed the sum of \$ 11.000.-- or 12.000.--.

3.) It should be stressed again that ICSU should do something for SCOR with regard to its finances. ICSU does support the Unions, it should do the same for SCOR as an inter-union committee, the more as the Unions themselves do not allocate any money to SCOR.

4.) Besides that we cannot expect that UNESCO-IOC has to bear the financial burden of the main lot of SCOR's expenses. This would produce a nearly complete dependency of SCOR on UNESCO.

SCOR has at present tasks of its own:

a.) The question of oceanographic documentation, which is solved for physical oceanography, but not for the other disciplines. At least one meeting would be necessary to start with this task (say \$ 6.000.--).

b.) It may happen that a WG on Atlases has to be established to find out the general line to produce them (about \$ 6.000.--).

c.) At the last General Assembly of ICSU it was resolved that SCOR should take part in the GEBCO question. \$ 10.000.-- would be necessary for the beginning.

Please look at the items 4. a, b, c, as a formal application, which the Treasurer may consider as

"Supplementary Estimates"
according to your letter of August 23, 1962.

Please bring with you the final audited budget of SCOR, January - December 1961, in 30 copies.

Please note that the Netherlands National Committee paid a contribution of hfl. 1000.--, which were transferred to the SCOR account 4137 a, being the sum of DM 1.105.10.

Dear Dr. Böhnecke,

Many thanks for your letter of 13 November.

You ask me to give you some indication of the result of the budget discussions in Prague regarding SCOR. I hope that this answer will seem reasonable to you.

We have many demands on our money for 1963 – more than ever before in the history of ICSU. We have many new projects, most of which have no possibility whatever of raising income even up to the level which you achieve. Therefore we have been unable to allocate to SCOR anything at all from the bulk subvention from UNESCO to ICSU of £175.000.

However, there is a possibility that the UNESCO subvention may be increased next year, and if this happens (and the eventuality was fully discussed in Prague), SCOR will be allocated the sum of \$5.000.

I hope that I will have good news for you in due course, but in any case I will keep you informed.

Dear Dr. Böhnecke:

In reference to your letter of 10 January, I am sorry that there continues to be a misunderstanding concerning the Unesco support for SCOR during 1963-64. The sum of \$70,000 given in the Programme and Budget is not only for SCOR but also for all of the operations of the Commission. The support for SCOR will be at least \$10,000 per year and possibly slightly higher if we find the money can be spared. During the next week the Marine Science Budget for 1963 will be approved in detail after which I can give you the exact figure for this year.

It should be noted that we also propose to spend additional funds which may be used on projects developed jointly with SCOR. For example, we are planning a second meeting of the Joint Panel on the Equation of State of Sea Water which will be held in Berkeley, 16 - 19 August 1963. I have also anticipated additional expenditures on the general problem of standardization and intercalibration, although the method of doing this must await the outcome of the SCOR meeting, and we have foreseen funds for travel and related expenses of the disciplinary experts for the Indian Ocean Expedition. By the time of the SCOR meeting I will have had the chance to discuss the budget with the appropriate officials here and we will know better how to proceed with this and other related projects.
